#### MEMBERSHIP AND AFFILIATION

Compliance with Perkins V legislations requires that every CTE program be affiliated with and actively involved in their aligned CTSO.

For all FCS programs, that is FCCLA!





#### MEMBERSHIP AND AFFILIATION

- The key to joining and involvement starts with the beginning of the year (course), FCCLA is the leadership organization for any FCS class. Include it on your course syllabus, whether in class or virtual
- The FCS teacher is regarded as the FCCLA adviser-YOU the ADVISER are the key to <u>affiliated</u>
  membership and an active chapter

#### MEMBERSHIP AND AFFILIATION

- What makes a chapter? 12 members and 1 adviser minimum
- Membership is \$12 (\$9 national & \$3 state) payable to national
- In 2021-22, four affiliation options are being offered, including three "packages"
- Can only be called FCCLA and use the resources when dues submitted to national office

#### THE PORTAL

- https://affiliation.registermychapter.com/fccla#
- A detailed tip sheet will be created yearly
- For <u>new chapters</u>, complete some info, (shown on the next 2 slides) submit and you will be sent a chapter ID # that will be used as your username in the future along with the password that you select (keep note of that!)
- Previously affiliated chapters, log in with the same info from the past and make the requested updates

#### VA MEMBERSHIP RECOGNITION

- Certificate to new chapters from our VP of Membership (sent to the principal)
- \$1,000 from the Leadership Foundation for new chapters (divided, based on a simple application and attending state conference)
- VA offers these recognitions: New Chapter, Middle Level Chapter, Milestone Chapters 50+, 100+, 150+ etc.

#### VA MEMBERSHIP RECOGNITION

- VA offers another recognition program created by the state officers- watch for this the end of September (creative for appeal and favors at state conference)
- Go for the Red membership recognition as seen on national website


